

## **Decision Number 17**

## **Know your Customer (KYC) Form**

The CMA Chairman/Governor of the Central Bank of Lebanon,

Pursuant to Law 161 of August 17, 2011 on Capital Markets, whereby the CMA is vested with all the powers pertaining to financial instruments,

And pursuant to the Decision of the Capital Markets Authority Board taken at its meeting of March 2, 2015,

## Declares the following,

Article One: The provisions of this decision shall apply to financial intermediation institutions, financial institutions, and banks dealing in securities in Lebanon.

Article Two: Following the issuance of this decision, any of the aforementioned institutions that wish to open accounts, to deal in/trade in securities as agent should:

- Adopt KYC form that contains at least the information in the attached form.
- Provide CMA with a copy of the said form.

The aforementioned institutions that deal in/trade in securities as agent in accounts opened before the date of publication of this decision will be granted till 1/1/2016 to apply the provisions of this decision.

Article Three: This Decision shall come into force upon its publication in the Official Gazette.
