



Closing Prices


The CMA Market Value Weighted Index (BDLSI: Reuters Ticker) closing price for the month of August 2022 was 1739.58 versus 2103.99 in June 2022 (decrease by 17.32 %). The YoY closing change for the months of August showed an increase of 201.21% from 2021 to 2022.

The CMA Banks Value Weighted Index (BDLSI1: Reuters Ticker) closing price of for the month of August 2022 was 199.50 versus 199.01 in July 2022 (increase by 0.248%). The YoY closing change for the months of August showed a decrease of 18.04% from 2021 to 2022.





Average Prices

- The average CMA Market Value Weighted Index indicated a decrease of 9.5% throughout the month of August 2022 to reach **2025.08** up from an average of **2237.54** in July 2022.
- The average CMA Banks Value Weighted Index increased by *0.15%* to reach **199.77** by the end of August 2022 vs. an average of **199.47** in July 2022.
- In the month of August 2022, the MVWI's High was 2150.19 and Low 1739.59.
- In the month of August 2022, the BVWI's High was 200.24 and Low 198.31.

BEIRUT STOCK EXCHANGE

August 2022 BRIEF

The month of August 2022 showed a decrease in trading activity when compared to July 2022, whereby the total traded volume declined by *23.18% to* reach **887.525** of traded shares in comparison to **1,155,299** of traded shares in July. Moreover, the Value of traded shares decreased by 33% to settle at around **\$33.447** Million versus **\$49.922** Million in July 2022.

GAINERS AND LOSERS

The stock with the highest increase in price in August 2022 was *Bank Audi* with an increase of 15.38% followed by *Ciments Blancs Nominal* (12.58%). As for the market losers, Solidere A was the worst performer for the month of August 2022 with a price drop of 9.58%.

NUMBER OF TRANSACTIONS

The total number of transactions incurred on the Beirut Stock Exchange increased in the month of August 2022 by 7.80% to 553 transactions up from 513 in the month of July 2022.

MOST ACTIVE SHARES

Among the most active securities in August 2022 was *Solidere A,* which comprised of *65.70%* of total trading value on the BSE, where **374,163 shares** traded in total. The second most active security by value was *Solidere B* with *28.77%* of total trading on the BSE **(164.405 Shares traded)**.

MARKET CAPITALIZATION

The Total Market Capitalization decreased by 5.69% and settled at 14,194,154,421.11\$ V/S 15,050,641,799.60\$ in the previous month. In addition, the Listed market capitalization decreased by 6.03% for the month of August 2022 to reach \$13.355 billion up from \$14.211 billion in the month of July 2022.
